#### **Detailed Rationale**

Informerics Valuation and Rating Private Limited (IVR) has assigned long-term rating of IVR BBB- with a Credit watch with developing implications and short-term rating of IVR A3 with a Credit watch with developing implications for the bank loan facilities of Cerebra Integrated Technologies Limited (CITL).

Rating on credit watch with developing implications is on account of remarks under Emphasis of matter under Auditor report for ABS FY21 regarding other non-current assets and advance given to subsidiary company outstanding for substantial period.

The rating draws comfort from the established track record of operations and experienced management, diversified customer base and healthy financial risk profile. However, these strengths are partially offset by volatility in margins and operating income and working capital intensive nature of operations.

IVR has principally relied on the standalone audited financial results of CITL upto 31 March 2021, 9MFY22 results and projected financials for FY22. FY23 and FY24, and publicly available information/ clarifications provided by the company's management.

#### **Key Rating Strengths**

#### • Established track record of operations and experienced management:

The company commenced its operations in 1992 and has a successful track record of around two decades in the existing line of business. Overall activities of CITL are managed by 9 directors as well as supported by qualified and well experienced management team.

#### Diversified customer base:

With presence of around two decades, CITL has established a healthy relationship with its customers and suppliers. The company caters to several government entities. Also, it caters to well established players such as Samsung India Electronics Limited and LG Electronics in the e-waste division. The company has built a strong track record which has enabled the company in bagging repeat orders from its clients.

#### Healthy financial risk profile:

Company has a strong net worth of Rs 234.48 crore as on March 31, 2021 backed by steady accretion to reserves. On account of low reliance on external debt, gearing is low at 0.05x as on March 31, 2021. Despite the high reliance on creditors, but backed by a strong networth, the TOL/TNW ratio is low at 0.25x as on March 31, 2021. On account of low reliance on external debt and healthy operating profitability, the debt-protection metrics are healthy, reflected in interest coverage ratio (ISCR) and debt coverage ratio (DSCR) of 2.84x and 2.26x respectively in FY 2021.

#### **B. Key Rating Weaknesses**

#### • Volatility in margins and operating income:

About 95% of the industry is handled by unorganized players, which operate without any license and use unscientific methods to treat e-waste. Hence the business performance is susceptible to the intense competition in the industry. The revenues were in the range of Rs. 60-270 crores in the past three fiscals, while also witnessing large variations in the operating margins. Total operating income (TOI) declined to Rs.63.90 Crore in FY2021 from Rs. 99.86 crore in FY2020. In 9MFY22 the company achieved TOI of Rs. 154.16 crore.

#### Working capital intensive nature operations:

The company has large working capital requirements which are reflected in an elongated conversion cycle 377 days in FY2021 (FY2020: 196 days). The average utilization of fund based working capital limits of the company stood high at ~83% during last 12 months ending 31st January 2022.

**Analytical Approach:** For arriving at the ratings, IVR has analysed CITL's credit profile by considering the standalone financial statements of the company.

#### **Liquidity** – Adequate

The liquidity of the company is expected to remain adequate marked by its adequate expected gross cash accruals as against its debt repayment obligations. The company has earned gross cash accruals of Rs. 4.96 crores in FY21 and expected to earn cash accruals in the range of ~Rs.17 – Rs. 85 crore as against debt repayment obligations in the range of ~Rs.0.80-Rs.1.29 crore during FY22-24.

#### **About the company**

Cerebra Integrated Technologies Limited, was initially established as partnership firm in 1992 and started its operation as manufacturing of computer systems and trading of its peripherals, components, etc. In 1993 it was converted to public limited company. CITL is currently engaged in the business of e-waste recycling, refining and refurbishment, electronic manufacturing services and IT infrastructure management. The company is listed on National Stock Exchange (NSE) and Bombay Stock Exchange (BSE).
