### **Detailed Rationale**

Infomerics has downgraded the ratings assigned to the bank facilities of Ishan Infotech Limited due to lack of adequate information available and the uncertainty around its credit risk. Infomerics assesses whether the information available about the entity is commensurate with its rating and reviews the same as per its policy.

The lenders, investors and other market participants are thus advised to exercise appropriate caution while using this rating as this rating may not adequately reflect the credit risk profile of the entity.

### Non-cooperation by Issuer

Infomerics has been regularly following up with the company to provide the required data to monitor its assigned rating to the bank facilities, vide email communications dated February 25, 2024, February 27, 2024, April 5, 2024, May 3, 2024, and May 6, 2024, and concurrently over several phone calls. However, despite the repeated requests by Infomerics, the company's management has not submitted the requested information for monitoring the ratings.

Availability of information is very critical in the rating exercise. In the absence of the requisite information, in consonance with SEBI guidelines, Infomerics has to review the rating based on the best available information. Accordingly, the ratings for the bank facilities of Ishan Infotech Limited aggregating Rs. 60.00 crore has been migrated to 'ISSUER NOT COOPERATING' category by Infomerics.
