Detailed Rationale

The reaffirmation of ratings assigned to the bank facilities of Sudharma Infratech Private Limited (SIPL) continues to derive strength from its long track record of operation under experienced promoters, reputed clientele base, comfortable and improving capital structure coupled with adequate debt protection metrices and revenue visibility marked by its strong order book position. However, these rating strengths continue to remain partially offset by customer concentration risk and SIPL's presence in highly fragmented & competitive construction sector. Further, the ratings also note moderation in its financial performance in terms of scale of operation and gross cash accruals in FY21.

Earlier the ratings were placed under credit watch with developing implications in view of uncertainty in operating scenario of the company and expected moderation in SIPL's financial performance in FY21 due to impact of COVID-19 induced lockdown and consequent problems in contract execution, now it is removed from credit watch with resumption of work in normal course since Q3FY21 coupled with normalcy in operating condition. Further, the outlook of the company remained negative attributable to expected hindrance in operations owing to second wave of COVID-19 in the country which may have a negative impact on the financial performance of the company in the near-term.

Key Rating Drivers with detailed description

Key Rating Strengths

Experienced promoters and long track record of operation

SIPL has established operational track record of more than a decade in construction of various civil infrastructure, roads and bridges. Mr. R.V. Sudhakar (Managing Director), is a first-generation entrepreneur having three decades of experience in the construction sector. The extensive experience of the promoter and successful track record of operation has helped the company in acquiring customers. The directors are well supported by a team of experienced and qualified professionals.

Reputed clientele base

The company caters to both government as well as private entities and has generated repeat orders from them. Further there is new addition to the customer base which in turn increases its scale of operation. At present, the company has orders from Ministry of Road Transport & Highways, Trichy Tollway Private Limited and Ashoka Buildcon Limited amongst many others.

Strong order book

Over the past years, the company has successfully completed many projects across Andhra Pradesh and Telangana. The company has completed many major as well as minor projects and has orders in hand of around INR 589.55 crore (Previous Year INR 485.47 crore) and an unexecuted order book of around INR 287.54 crore to be executed by March 2022.

Comfortable and improving capital structure and debt protection metrics

The capital structure of SIPL were comfortable with an overall gearing of 0.72x (Previous Year: 1.12x) and long-term debt equity ratio of 0.47x (Previous Year: 0.79) as on March 31, 2020. The total debt to gross cash accruals stood comfortable at 1.91x at the end of FY20 as compared to that of 3.47x at the end of FY19. The company further estimated an improvement in its capital structure with expected improvement in its leverage ratios as on March 31, 2021.

Key Rating Weaknesses

Customer concentration risk

The present order book contains rehabilitation, up-gradation and repair of road construction in Tamil Nadu and Andhra Pradesh. However, top 5 customers account for almost 96.29% of total operating income in FY20 indicating a concentrated customer profile. Nonetheless, the company has adequate experience in order to execute projects in these states which provides a comfort.

Highly fragmented & competitive nature of the construction sector with significant price war

The domestic infrastructure/construction sector is highly crowded with presence of many players with varied statures & capabilities. The boom in the infrastructure sector, a few years back resulted in an increase in the number of players. While the competition is perceived to be healthy, significant price cut by few players during the bidding process is a matter of serious concern for the users with respect to quality of output.

Decline in topline and profitability during FY21

The company's total operating income (TOI) has declined from INR 154.89 crore in FY20 to INR 87.23 crore in FY21 (estimated). This is mainly because of the COVID-19 pandemic induced lockdown resulting in a huge shortage of materials, manpower and resources in the state of Andhra Pradesh. With decline in TOI and increase in operating expenses the profit levels of the company are also expected to decline in FY21. However, substantial work had resumed since Q3FY2021 which helped the company to reach ~85% of its projected TOI of FY21.

Liquidity - Adequate

The company has been able to generate a comfortable level of gross cash accruals (GCA) in FY20 of INR 13.57 crore and expected to generate ~Rs.10.5 crore in FY21. The liquidity of the company is expected to remain satisfactory in the near to medium term in absence of any significant term debt repayment. Thus, the overall liquidity position of the company is expected to remain **Adequate** in the near term. However, the liquidity is dependent on successful completion of projects and speedy realisation of contract proceeds.

Sudharma Infratech Private Limited (SIPL) was incorporated in 2008 in Andhra Pradesh, the company is promoted by Mr. R.V. Sudhakar who is the managing director. SIPL is engaged in contract-based construction and renovation of roads and highways from various Government bodies of Andhra Pradesh.
